



WHAT YOU NEED TO KNOW OVERDRAFTS AND FEES

An overdraft occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two ways.

1. We have overdraft protection plans (*Courtesy Coverage, Courtesy Coverage Plus*) that can be available on your account.
2. We also offer overdraft transfer plans, such as a link to a savings account or line of credit, which may be less expensive than our overdraft protection plans (*courtesy Coverage, Courtesy Coverage Plus*). To learn more, ask us about these plans.

This notice is to explain our *overdraft protection plans (Courtesy Coverage, Courtesy Coverage Plus)* Practices.

What are the overdraft protection plan (Courtesy Coverage) options that come with my account?

- Checks and other transactions made using your checking account number
- Automatic bill payments using ACH

We do not authorize and pay overdrafts for the following types of transactions unless you ask us to (*Courtesy Coverage Plus*)

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we do not guarantee that we will always authorize and pay any type of transaction.

If we do not authorize and pay an overdraft, your transaction will be declined.

What fee will I be charged if Arbor Financial pays my overdraft with Courtesy Coverage and/or Courtesy Coverage plus?

Under our overdraft protection plans (*Courtesy Coverage, Courtesy Coverage Plus*)

- We will charge you a fee of \$35 each time we pay an overdraft.
- There is no limit on the total fees we can charge you for overdrawing your account.
